Eligible Breeds & Registry

1. Open to all dogs at least **12 months** of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the AKC Canine Partners program.
2. Mixed breeds must be spayed or neutered to be eligible to run. AKC registered dogs with breed disqualifications may be entered.
3. Not AKC registered? – NO PROBLEM! You will can register your Canine Partner with AKC. Download the registration form at: <http://www.akc.org/dog-owners/canine-partners/enroll/>
4. REFUNDS: Bitches in season and lame dogs will be refused entry and, if presented at inspection, will be refunded entry fees. Refunds

for other absences or withdrawals made after the event entry closing date will not be made.

Event Schedule

Trial Hours: 9:00 A.M.-3:00 P.M. unless runs are completed

We will have “rolling inspections” and runs.

Please Check in for inspection 15 minutes prior to your race time.

Day Off Registrations will be accepted as space allows.

For Fast CAT we typically run dogs in flights of 5 to allow catchers to be ready on the opposite end. It is also the responsibility of each entrant to make an effort to be ready when their dog's flight is called. Please follow all instructions of the field crew in order to ensure a smooth and efficient flow.

Entrants must provide their own catchers/holders.

Directions to Site

Interstate 15 (northbound): Take Exit 93, toward ID-39/Blackfoot/Arco. Merge right, turn left, approximately 1.1 miles, onto SW Main St/US-91. Reserved Overnight Parking and Obedience and Agility Parking, is on the backside of the Fairgrounds. Turn left on Highland Drive after passing Fairgrounds and then left on Jones Street.

Interstate 15 (southbound): Take Exit 93, toward ID-39/Blackfoot/Aberdeen. Turn left, approximately 1.1 miles. Turn left onto SW Main St/US-91. Reserved Overnight Parking and Obedience and Agility Parking, is on the backside of the Fairgrounds. Turn left on Highland Drive after passing Fairgrounds and then left on Jones Street.

For Day of Show parking, follow directions above but then turn left on Park St. in front of the Fairgrounds. Day of Show parking is straight ahead.

Food/Water/Shelter

Weather in Idaho is a guessing game! We could have 90 degree heat or heavy rain! Please be prepared for either. There will be limited shade available. We do our best to run the dogs as soon as we can once their Heat

is called but please bring water for yourself and dog. Be prepared for anything especially June.

Ribbons & Prizes

Fast CAT: Light Blue flat ribbon for qualifying score.

PKC will offer a “New Title” rosette for any dog finishing a title.

Eligible Breeds & Registry

Females in season may not enter

Open to all dogs at least 12 months of age that are:

Individually registered with the AKC,

Recorded in the FSS program,

Dogs enrolled in the AKC Canine Partners program with PAL numbers

A dog may enter only once per event (an event is defined by an event number).

If you have a mixed breed dog or dog that is otherwise ineligible for AKC registration you can enroll the dog with the AKC Canine Partners listing. You can enroll your dog at the test site by completing the Canine Partner form in this premium.

Test, Titles and Timing

Fast CAT is a timed straight 100-yard dash for dogs. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen.

The course is completely fenced, and dogs are run individually.

Dogs are timed when they complete the 100-yard dash. The time is converted to Miles Per Hour (MPH).

FORMULA: $204.545 / \text{RUN TIME} = \text{MPH}$

$\text{MPH} \times \text{HANDICAP} = \text{POINTS}$ (ROUNDED TO NEAREST 0.01)

Based on the dog's size at the withers, a handicap is applied and points are earned:

- 18" or greater = Handicap is 1.0
- 12" up to less than 18" = Handicap is 1.5.
- Below 12" = Handicap is 2.0.

$\text{MPH} \times \text{HANDICAP} = \text{POINTS}$

Titles are earned at specific point levels and the highest suffix may appear after the dog's name:

BCAT = 150 points **DCAT** = 500 points **FCAT** = 1,000 points

FCAT# = Each additional 500 points

Coursing is an athletic activity that can tax a dog's and owner's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection Committee has the authority to disallow a dog's entry into a test and, in such instances, applicable entry fees will be refunded. Dogs will be examined for lameness before running.

ALL DOGS RUN AT OWNER'S SOLE RISK

- All AKC rules regarding sportsmanship and conduct apply.
- All entries must be 12 months of age or older on the day of the test.
- Bitches in season and lame dogs will be excused.**
- Each dog requires an individual entry. You may use one form to enter one dog for all events. Use the checkbox and mark off each event you wish to enter, \$20.00 per entry.
- The Huntmaster is responsible for field safety and therefore he/she is in **complete charge of all dogs and handlers on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course.**
- This is an outdoor event. Please plan accordingly. **Please bring your own shade, chairs and water.**
- The club recommends using a plain buckle collar or slip lead. Muzzles are allowed. **No pinch collars, flexi leads, harnesses or no electronic training collars or devices are allowed.**
- Please pick up after your dog so we can continue to use this wonderful facility. Any exhibitor caught not cleaning up after their dog will be asked to leave the trial grounds. No refund will be given if this occurs. A \$5.00 fine will be assessed for any loose dog on the field not competing.
- Dogs should be warmed up before and cooled down after running.
- An electric, continuous loop, plastic strip lure machine will be used.
- The show grounds are not completely fenced. The FAST CAT course will be fenced.
- Dogs must be on lead or crated unless running.
- You are responsible for controlling your dogs and children.
- Persons exhibiting conduct detrimental to the AKC/SNJGSDC and any dog(s)/other person(s) will be asked to leave the trial site by the Field Committee, maybe disciplined by the AKC, and entry fees will not be refunded.
- No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the event-hosting clubs.**
- PKC, its agents, members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.
